AP Exams: Important Information

All students enrolled in an Advanced Placement (AP) courses should have registered for their May exams in class. Seniors are the **only** students who can opt out of taking the AP Exam in May; the **DEADLINE FOR SENIORS TO DECLINE TAKING THEIR AP EXAMS IS TUESDAY, OCTOBER 1.** Forms can be picked up in College Counseling and the Registrar's Office in North Hall. They must be completed and turned into the Registrar by the end of the day on October 1. Exams are being ordered on October 4. Again, only seniors have the option of declining the exams.

Financial Aid Forms are (almost) Available!





As of October 1, the 2020-2021 Free Application for Federal Student Aid (FAFSA) will be available! Before completing the FAFSA, both students *and* parents will need to register for a Federal Student Aid ID (FSA ID), which serves as both a login to the FAFSA and a legal signature. Once created, each FSA ID is verified through the Social Security Administration and can take a few days to be approved. We encourage families to

continue to check their email for more details from the Department of Education. Applicants for aid in the 2020-2021 school year will need to have access to their 2018 federal tax returns.

Please note, each college has its own financial aid application requirements. Some colleges will only require families seeking need-based aid to complete the FAFSA; others will also ask for the CSS Profile; others will ask for institutional-specific forms – our seniors and their families need to keep track of required forms and deadlines. Remember, similar to college admissions, financial aid opportunities vary from college to college; what one college may consider when reviewing a file is different

from another. As a result, it is difficult to generalize what all colleges will do in a given situation; the answer is often "it depends." Mr. Weisgold is happy to help senior families with questions specific to financial aid.

Coming to College Counseling

This fall, we plan to host nearly 150 colleges and university representatives in College Counseling. These meetings, typically 45-minutes sessions, allow our students to get to know more about specific programs but also give colleges and universities the opportunity to learn more about Bullis.

Seniors are welcome to come to meetings (with permission 24-hours in advance from their teachers) and can sign up through Naviance. Juniors may attend *only* if they have Study Hall during the time of the scheduled visit.
